There may also be warranty standards specific to the state in which your home is located so be sure to read your warranty book thoroughly. You should also familiarize yourself with its definitions, limits of coverage and warranty resolution process.

WORKMANSHIP & MATERIALS

Year one warranty items that do not meet warranty standards in the first year of the warranty period will be corrected by the builder.

STRUCTURAL ELEMENTS

In the unlikely event that your new home develops a warranted structural defect as defined in your warranty book, the defect will be corrected by the warrantor.

MAINTAINING YOUR HOME

With any new home, ongoing maintenance is necessary and is the homeowner's responsibility. Your builder can assist you in understanding how you can take care of your home to avoid problems.
